

CONTACT LENS EVALUATION FEE

We want to thank you for considering a contact lens evaluation with the doctors of Abrams EyeCare Associates. We would like you to understand what is involved with a contact lens evaluation and if you have any questions, please do not hesitate to ask. At the time of your examination you may choose to learn insertion and removal or schedule another appointment for your contact lens training. As long as we have your prescription in stock, we will dispense them to you that day. Otherwise, if they need to be ordered, we will schedule an appointment for dispensing once received.

Based on Indiana law your contact lenses must be evaluated with a doctor examination on a yearly basis in order to refill your prescription.

The charges for the contact lens evaluations are as follows:

First time Contact Lens Fitting: Change in contact brand or type **Fee: \$70.00**

Change because of unknown contact lens specification
Change because of poor fit or visual acuity

Specialty Contact Lens Fitting: **Fee: \$95.00**
Astigmatism, Bifocal or Keratoconus Contacts

Renewal of Contact Lens Fit and Power: **Fee: \$50.00**
This additional exam allows you to refill your contact lenses for one full year

Notice: Your evaluation/fitting fee covers your trial lenses and up to 2 months of follow-up care. Follow-up care is vital to determine the fit of the lens and to protect the health of the eye. If you elect to forego the follow-up care and return beyond the initial 2 month period, you will be charged a refitting fee of \$25.00. We do urge you to protect your vision and return for the follow-up care. Trial lenses are not for permanent use. You must have follow-up care to be able to buy contact lenses. The prices of contact lenses will vary depending on the type of contacts that your doctor recommends and your prescription.

Your contact lenses must be paid in full before you wear them out of the office. Changes in your contacts can be made within the first 2 months. If within the 2-month follow-up period, you feel that contact lenses are not for you, then we will credit your account for the portion of the contact lenses that is refundable. Lenses are returnable if they are in the original bottles or unopened boxes. You may use this credit towards glasses or for a purchase by another family member.

THE EVALUATION/FITTING FEE IS NOT REFUNDABLE OR CREDITED

Fairness to Contact Lens Consumers Act: This act went into effect February 4, 2004. As stated by this act, you will be given a copy of your contact lens prescription once the prescription is finalized with the examining doctor. Receiving a trial lens IS NOT a finalized prescription. A finalized prescription is determined at the follow up appointment after you have been wearing the trial lenses. The doctor will approve the fit and vision with the contacts. At this point, you may receive a copy of your prescription.
